	MedU Virtual Patient Cases - iNtIME develops and distributes virtual patient cases designed for use by third year medical students under its MedU umbrella. Currently, iNtIME offers virtual patient cases in pediatrics (Computer-assisted Learning in Pediatrics Program - CLIPP), in internal medicine (Simulated Internal Medicine Patient Learning Experience - SIMPLE), and family medicine (Family Medicine Computer Assisted Simulations for Educating Students - fmCASES). Additionally, iNtIME collaborates with New York University to distribute the surgical education modules created similarly to iNtIME's cases (Web Initiative for Surgical Education of Medical Doctors - WISE-MD). eCLIPPs (extended CLIPP scenarios) continue to be developed with an anticipated evolution to a program to be named Foundations. Foundations will cross the medical disciplines of MedU providing for consistency in pedagogy and offerings in content such as professionalism in medicine, culture in health, and the like. MedU virtual patient cases are offered by subscription through iNtIME. To date, iNtIME has over 320 institutional subscriptions to its virtual patient cases from medical institutions in the U.S., Canada, and beyond. Each discipline experienced subscription growth over last year. To further iNtIME's mission and to ensure the teaching content of the virtual patient cases remains current and aligned with nationally accepted curricula, each case set has an editorial board consisting of editors-in-chief, associate editors, and case editors, all of whom are tasked with maintaining the quality of the case content. Additionally, the editors-in-chief of each case set join together to form the MedU Editorial Board. The MedU Editorial Board works to ensuring the iNtIME offerings meet the needs of students, teaching faculty, and subscribing institutions. In addition to its virtual patient cases, iNtIME, offers teaching tools and user support. The password-protected area of its MedU Web site offers integration tools, suggested ways in which the cases can be used to meet accreditation requirements, case summaries, a case list, a case search tool, access to the cases and access to student case use log data. iNtIME staff and collaborators also support iNtIME subscribers through workshop offerings at national meetings, availability at national exhibits, and through individualized tutorials. Associated with the case sets are assessment tools. CLIPP offers a validated exam, including a scoring service, to its subscribers. fmCASES is in the process of validating its question bank and will offer an exam for the next academic year due to begin in July 2011. SIMPLE has begun the development of an assessment tool slotted for pilot testing beginning in July 2011. And WISE-MD has begun to incorporate assessment questions into their modules. Important to iNtIME's mission is collaborative research. With the organization's increase in revenue over last year, iNtIME will begin dedicating funds to research offered in the form of grants to subscribers and collaborators. Even though many of the organization's collaborators have furthered research efforts on their own utilizing MedU's virtual patient cases, funding such opportunities is a new initiative for iNtIME. With iNtIME's growth, the organization has expanded its staff to include an individual skilled in the ways of technology. In order for iNtIME's offerings to remain innovative and continue to further its mission, it was necessary to bring expertise of this caliber in house. This too will assist in iNtIME furthering its mission.
