New Hampshire Professionals Health Program shall educate, help in the prevention of the impairment of health care professionals, identify, refer to treatment, guide, and monitor the recovery of health care professionals at risk or suffering from substance use disorders and mental and/or physical illness.

The New Hampshire Professionals Health Program was developed to work with referred health care professionals for substance use disorders and mental and/or physical illness. The Program involves assessment followed when appropriate by contracted treatment and monitoring usually in a diversionary setting. Services are available to all licensed medical professionals and residents who practice in NH or seek licensure in NH regardless of their location. In 2009, 39 health care professionals received services including 7 new referral contracts generated by hospital presentations.
