	Our curriculum at Kent Place best expresses our commitment to challenging girls, inspiring their love of learning and offering the richest education possible. Classes are taught by faculty who are masters in their fields and passionate about learning. Visual and performing arts, as well as sports instruction, are available to students at every grade level. In a typical year, more than 90 of Upper School students devote over 7,000 hours to community service. Students have also traveled as far as Kenya and Tanzania to engage in community service projects through our Global Service Learning Initiative. Kent Place also offers summer programs with traditional day and enrichment camps, and the Girls Leadership Institute, for 7th and 8th graders, is celebrating its 16th anniversary in 2011. Kent Place also has an Adult Learning Institute, School Store on campus and online, Afterschool Enrichment programs and Extended Care, and a Green Campus Initiative. Our Ethics Institute, a first-of-its-kind at the elementary and secondary school levels, believes that fostering ethical thinking and ethical decision-making in the youngest of children prepares them to be the most effective leaders and compassionate citizens of tomorrow.
