The Bickford Theatre produces four (4) main stages performance and three (3) A La Carte series presentations annually. There were 18,780 people in attendance for theatre productions (including main stage, children's shows, jazz, adult shows, special concerts and a la carte performances). Approximately 15,000 brochures advertising offerings were mailed to members of the museum and to addresses gathered from rented and internal mailing lists. Brochures are also displayed throughout the museum. Approximately 1,500 Playbills were printed for each of the main stage plays.
