

ARE IN COLLEGE, AND 60% ARE CURRENTLY EMPLOYED. LONG TERM RESULTS CAN
BE SEEN WITH OUR YOUTH THAT GRADUATE TO OUR ANCHOR LINE PROGRAM. YOUTH
