LIBERTY SCIENCE CENTER, LOCATED AT THE BOOMING JERSEY CITY WATERFRONT IN LIBERTY STATE PARK, CELEBRATED ITS GRAND REOPENING JULY 19, 2007, FOLLOWING A 22-MONTH, \$109 MILLION UPGRADE OF ITS EXHIBITION, PROGRAM AND THEATER EXPERIENCES IN FACILITIES THAT HAVE BEEN ENLARGED AND MODERNIZED WITH IMPROVEMENTS SUCH AS NEW RESTAURANT AND RETAIL AMENITIES. THE PURPOSE OF THE 295,000-SQUARE-FOOT CENTER, IS TO BE A UNIQUE AND ENGAGING RESOURCE ABOUT THE SCIENCE AND TECHNOLOGY OF LIVING, LEARNING AND WORKING IN THE NJ-NYC REGION.
