EDUCATION BOSTON WOMEN'S FUND, INC. PROVIDES EDUCATION TO MEMBERS OF THE PHILANTHROPY COMMUNITY ABOUT THE IMPORTANCE OF FUNDING GENDER SPECIFIC PROGRAMMING, PARTICULARLY RACIAL, SOCIAL, AND ECONOMIC JUSTICE ACTIVISM. THIS IS DONE THROUGH PRESENTATIONS AT CONFERENCES AND TRAININGS AS WELL AS INFORMALLY AT VARIOUS PHILANTHROPIC EVENTS. BWF ALSO PROVIDES RESOURCES AND EDUCATION TO ITS SEVEN CONSTITUENT COMMUNITIES ABOUT THE PHILANTHROPIC COMMUNITY AND STAFF AND COMMUNITY DEVELOPMENT CONFERENCES AND TRAININGS. YOUNG SISTERS FOR JUSTICE (YSFJ) IS AN INNOVATIVE YOUTH-LED, COMMUNITY BASED LEADERSHIP PROGRAM. YSFJ INVOLVES A DIVERSE GROUP OF YOUNG WOMEN IN A TWO-YEAR INTERNSHIP. PARTICIPANTS LEARN ABOUT POWER DYNAMICS, MOVEMENT BUILDING, AND HOW TO SHAPE PROGRESSIVE PHILANTHROPY AND WORK TO PROMOTE THE BROADER VISION OF SOCIAL, RACIAL AND ECONOMIC JUSTICE. ORGANIZATIONALLY, THE YSFJ MEMBERS ARE VOTING MEMBERS OF THE ALLOCATIONS COMMITTEE, AND HAVE ACCESS TO BWF'S STAFF DEVELOPMENT RESOURCES AND TRAINING. MEN TAKE A STAND. MEN TAKE A STAND WAS PRESENTED AS A PROGRAMMATIC INITIATIVE OF THE BOSTON WOMEN'S FUND AT THE MASSACHUSETTS STATE HOUSE IN FEBRUARY 2010 WITH A ONE-WEEK EXHIBITION OF PHOTOGRAPHS BY THE LATE ROBERT L. HAGGINS FOCUSING ON MALCOLM X, HUMAN RIGHTS ACTIVIST. THIS INITIATIVE HAS ATTRACTED THE SUPPORT OF PROGRESSIVE MEN IN THE GREATER BOSTON AREA IN BACKING THE LEADERSHIP OF WOMEN WITHIN ALL LEVELS OF OUR SOCIETY.
