Shelter Program: In the 2010 Fiscal Year, the shelter program housed 145 individuals for a total of 6,675 nights. Of those clients that left the program, 35 individuals were able to move to apartments without the assistance of a subsidy. An additional 20 clients moved in with family and friends and 13 clients were able to find placement in a transitional housing program. Of those clients that left the shelter program, 50 were able to secure employment income. WARM also received 346 calls looking for shelter.

4b (Code:) (Expenses \$ **101,815** including grants of \$) (Revenue \$ **20,856**)
Harvest Homes: In the 2010 Fiscal Year, the Harvest Homes program took in 18 families which consisted of 28 adults and 37 children. The Harvest Homes program provided 10,274 overnights to families that would have otherwise been homeless.

Outreach: In the 2010 Fiscal Year, the WARM's outreach program was able to serve 298 households. This consisted of 455 adults and 360 children. In total, WARM distributed \$23,767.50 to these families in the form of financial assistance for rent, utilities, hotel/motel vouchers, and prescriptions.
