Termination of the PowerOptions program would have jeopardized the supply and education strategies of many of PowerOptions 500 members, resulting in increased costs to taxpayers and charitable institutions, such as hospitals, universities and museums. PowerOptions now has a self-perpetuating board with staggered terms, separate Board committees for audit, executive compensation and governance, with appropriate governance policies which had previously been governed by MassHEFA. PowerOptions continues to be associated with a state quasi - governmental agency which focuses on clean energy development. PowerOptions continues to support charitable and governmental entities with their energy procurement through both supply arrangements and educational guidance in energy-related decision-making**
