


Rescue and Restoration Projects:

Combat sex slavery through prevention, rescue and rehabilitation of trafficking survivors. In 2010 146 girls in Nepal received literacy training; 252 girls, their families and their villages were educated in trafficking prevention; 470 women received literacy training; 1,100 girls were intercepted from potentially being trafficked into India; 215 at-risk girls received training in income-generating business skills

4b (Code:) (Expenses \$ 383,181. including grants of \$ 91,982.) (Revenue \$ 0.)
Economic Empowerment:

Consists of vocational training and self help groups where poor and marginalized women gain economic literacy, micro-loans, life skills, and grow in Christ. In 2010, 1,246 women were trained in income generating businesses; 631 women were awarded micro-loans to start small businesses; 6,600 family members benefitted from improved household income; 34 new groups started, totalling 25,500 women in Transformation Groups; 1,700 Transformation Groups currently active across India.

Education Projects:

Focus on at-risk children with an emphasis on educational opportunities for girls. This includes elementary schools, nonformal educational programs, and help for low-income families to keep children in school along with the love of God in Christ. In 2010, approximately 3,000 children benefitted from nonformal education and personal care; 600 children of displaced families benefitted from elementary school education; 470 women received literacy training; 1,323 children of impoverished families received educational help; 26 women were trained and provided medical care for 22,500 villagers in India.
