The Alexander Dawson School in Boulder County, Colorado, a \$33.5 million facility built by the Alexander Dawson Foundation in 1970, provides a rigorous, college preparatory educational program that challenges 460 students in kindergarten through grade 12 to achieve excellence in mind, body, and character. During the 2009-2010 school year, the school provided \$853,868 in financial aid to 67 deserving and talented students who otherwise would not have been able to afford a Dawson education. In June 2010, the school awarded diplomas to 26 graduates, who were accepted to such colleges as Clemson University, Duquesne University, University of Southern California, Villanova University, Stanford University, University of Colorado, Southern Methodist University, and University of Georgia and who were offered \$1.3 million in scholarships. Among the graduates was a National Merit Finalist. In addition, the school owned and operated a summer camp in 2009 that offered instruction and activities in music, sports, academics, art, drama, technology, engineering and science for 1,295 boys and girls.

The Alexander Dawson School in Las Vegas, Nevada, a \$37.7 million facility built by the Alexander Dawson Foundation in 2000, provides a rigorous, college preparatory educational program that challenges 624 students in pre-kindergarten through grade 8 to achieve excellence in mind, body, and character. During the 2009-2010 school year, the school provided \$1,692,620 in financial aid to 128 deserving and talented students who otherwise would not have been able to afford a Dawson education. In June 2010, the school graduated 60 eighth-graders, who have gone on to attend local public and independent high schools as well as such boarding schools as Choate Rosemary Hall and Stevenson School.

The Center for Excellence in Teaching and Learning offered free academic summer programs for high achieving, public school students in Las Vegas, Nevada and Boulder County, Colorado. The Center recruited top educators locally and from across the country and the United Kingdom to present advanced, problem-based projects to talented junior high school students recommended by local public school principals. During July and August 2010, approximately 100 sixth and seventh graders participated in a five-week program and 42 sixth and seventh graders participated in a two-week program in Las Vegas. Approximately 34 sixth and seventh graders participated in a five-week program in Boulder County, Colorado. Over 240 students participated in a one-day Brookings/UNLV program on the campus of UNLV. All of the program's costs were borne by the Alexander Dawson Foundation; there was absolutely no cost to the participants.
