	The Carlisle Area Health & Wellness Foundation (CAHWF) provides funding for grants and initiatives that seek to improve individuals' health status and community health capacity. The Foundation's central purpose is to provide support to programs aligning with the five Board-adopted focus areas. Toward that goal in 2009-10 the total giving to responsive grants was \$2,184,322 and related percentages for the focus areas were: Chronic Disease-29%, Primary Healthcare-28%, Oral Health-23%, Behavioral Health-12%, and Allied Healthcare-7%. Healthy People Grants received 1% of funds. Grants were provided to 32 nonprofit organizations. Additionally, beyond responsive grantmaking CAHWF develops initiatives to proactively address issues. The total funding for 2009-10 of \$80,154 supported such efforts as Wellness at Work, Postpartum Adjustment Support Group and Training, and Safe Routes to School. The five programs at the Sadler Health Center are so critical to the Foundation's mission and the community's basic healthcare needs that in total they receive approximately 50% of grant funds. The services offered through this community health center include: traditional medical and dental care, Healthy Rx, which has secured over \$10 million in free prescriptions in just over four years, tobacco cessation, with a highly successful 50% quit rate, and Nurse Family Partnership, a nationally respected evidence-based program. In the Statement of Functional Expenses, CAHWF reports that 82% of its funds supported program services in 2009-10. On average a grant leverages over \$3.00 from other resources for every \$1.00 the Foundation invests. Services that go above and beyond those of many foundations include free, or at little cost, training on outcome evaluation and other capacity building and nonprofit efforts. Additionally CAHWF leads or supports much collaboration such as Carlisle Regional Advocates for Nutrition and Activity and the Cumberland County Partnership for a Healthy Community.
