RESTATED ARTICLES OF INCORPORATION OF CENTER FOR VISION LOSS ENDOWMENT FOUNDATION

1. The name of the Corporation is Center for Vision Loss Endowment Foundation (the "Corporation").
2. The location and post office address of its current registered office in the Commonwealth of Pennsylvania is 845 Wyoming Street, Allentown, Lehigh County, PA, 18103.
3. The Corporation was incorporated under the Pennsylvania Non-Profit Corporation Law of 1933 and/or any successor Act (as amended) and is organized exclusively for charitable and education purposes within the meaning of §501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions or sections of any future United States Internal Revenue Code or Law (hereinafter as the "Code"), including, for such purposes, the making of distributions to organized organizations that qualify as exempt organizations under the §501(c)(3). Included among the charitable and educational purposes for which the Corporation is organized are as follows: To solicit, invest and manage charitable contributions and to use those contributions exclusively for the benefit of, and for the funding of the programs and services of, Center for Vision Loss, Inc., a Pennsylvania Not-For-Profit Corporation.
4. a) The Corporation does not contemplate pecuniary gain or profit, incidental or otherwise. Notwithstanding the generality of the foregoing, whenever the lawful activities of the Corporation involved, among other things, the charging of fees or prices for services or products, the Corporation shall have the right to receive such income and, in so doing, may have net earnings. All such net earnings shall be applied to the operation and maintenance of the lawful activities of the Corporation. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons,

except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make distributions in the nature of grants, gifts, and contributions solely to the Center for Vision Loss, Inc., a non-profit 501(c)(3) corporation under the Code. The Corporation shall not be authorized to make any payments or distributions to any other organization or entity other than Center for Vision Loss, Inc.

b) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign of or an opposition to any candidate for public office.

c) Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by (i) any corporation exempt from Federal income tax under §501(c)(3) of the Code, or the corresponding section of any future Federal tax code or (ii) a corporation, contributions to which are deductible under §170(c)(2) of the Code, or the corresponding section of any future Federal tax code without limiting the generality of the foregoing: (i) the Corporation shall not engage in any prohibited transaction within the meaning and intent of Section 503 of the Code; (ii) the Corporation, its members and directors, shall not engage in any prohibited act of self-dealing within the meaning and intent of §4941 of the Code; (iii) the Corporation shall expend and distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by any such application Section of the Code; (iv) the Corporation shall not retain any excess business holdings within the meaning and intent of §4943 and §4947(b)(3) of the Code; (v) the Corporation shall not make any taxable investments within the meaning and intent of §4944 of the Code; (vi) the Corporation shall not

make any taxable expenditures within the meaning and intent of §4945 of the Code; and (vii) the Corporation shall observe and conform to the corresponding sections of any future Federal tax code regulating, limiting or prohibiting any of the foregoing conduct.

5. The term of the Corporation's existence is perpetual.
6. The Corporation is organized on a non-stock basis.
7. The Corporation shall have members.
8. The Corporation shall have a Board of Directors of not more than ten natural persons of full age who shall be members of the Corporation.
9. Upon the liquidation or dissolution of the Corporation for any cause whatsoever, or upon the abandonment of any of its assets, neither the assets of the Corporation, nor any right therein, shall inure to the benefit of any of the directors, officers, members or any other private individual, but all assets or rights therein, or the proceeds thereof, after paying or making provision for the payment of all of the liabilities of the Corporation, shall be distributed to the Center for Vision Loss, Inc., a Pennsylvania non-profit corporation, if it is then in existence and then exempt under §501(c)(3) of the Code, or the corresponding section of any future Federal tax code, but if the Center for Vision Loss, Inc. is not then in existence and exempt under §501(c)(3) of the Code, or the corresponding section of any future Federal tax code, all assets of the Corporation or rights therein shall be distributed as determined by the Board of Directors to one or more organizations described in §501(c)(3) the Code, or the corresponding section of any future Federal tax code. Any assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
