2 The organization is a participant in Pennsylvania's Educational Improvement Tax Credit Program (EITC) authorized under Act 4 of 2001. Under the program, businesses apply to the Department of Community and Economic Development (DCED) to receive state tax credits for contributions made to scholarship or educational improvement organizations. The organization is required to contribute 80% of its annual receipts under this program as grants to a public school for innovative educational programs that meet the requirement of Act 4.3. As a participant in Pennsylvania's EITC program, Warwick Education Foundation is required to submit an annual statement on receipts and eligible expenditures to Pennsylvania's DCED.

4 Since the EITC program's inception, many businesses within the community have responded generously by designating Warwick Education Foundation as the recipient of their contribution. As a result, this concentration of contributions has impacted the support schedule for the look back years.

5 The organization receives support from the Warwick Community as a whole. It is not supported by members of a single family.

6 The organization is well organized, conducts regular board meetings, and has a diverse governing body of representatives which include community leaders.

7 The organization has a definite program in place to promote education within the Warwick School District.
