Scholarship Programs The California Nurses Foundation administers several scholarship programs designed to provide continuing funds from which scholarships are made to Registered Nursing students and licensed Registered Nurses for academic preparation and continuing education Awards during FY 2009-2010 were from one of those programs, as follows Region 11 Scholarship Program - Awards granted to 36 individuals, totaling \$ 37,289 70

Nurse Mentor/Preceptor Program This program provides nurse mentor and nurse preceptor services designed to support inexperienced RNs and experienced RNs returning to bedside nursing after a hiatus in acute care work, or when transferred to a new hospital unit Specifically, the program is designed to increase retention, including the retention of a culturally diverse nursing staff, by pairing newly hired or returning nurses with trained and experienced nurse mentors who reflect the cultural, linguistic and gender backgrounds of the nurses they support The mentors and preceptors provide one-on-one professional and personal support to improve patient care and abate the shortage of registered nurses by improving retention in the nursing profession During this fiscal year, two mentor programs and one preceptor certification program were conducted for Registered Nurses at a large urban hospital that is part of a county public health system Four staff nurses from that facility completed a course titled Educate the Educator and assisted in teaching programs through which 55 mentors and 35 preceptors were certified and began providing services At another facility, 20 Registered Nurses who had been certified as mentors through this program in earlier years received a refresher course and continued providing training and support interventions for their nurse colleagues designed to increase job satisfaction, enhance patient care skills and reduce nurse turnover

CNF Disaster Relief Fund During this fiscal year, the Disaster Relief Fund supported the Registered Nurses Response Network (RNRN), a project of the California Nurses Foundation, which continued to build and coordinate a national network of direct-care registered nurse volunteers willing to be deployed to disaster stricken areas where and when they are needed most Most of RNRN's efforts during this fiscal year were focused on relief efforts in the aftermath of the devastating earthquake that struck the island nation of Haiti on January 12, 2010 RNRN coordinated relief work with the United States Navy and with Hospital Sacre Coeur A total of ten RNRN volunteers were sent to work aboard the USNS Comfort, a mobile medical and surgical services ship that was deployed to Haiti to provide disaster and humanitarian relief The RNRN volunteers lived and worked aboard the ship, relieving exhausted military personnel and treating patients who were transported for hospitalization to the ship while it was anchored off the coast of Haiti An additional 44 RNRN volunteers were sent to Hospital Sacre Coeur in Northern Haiti to work in the main hospital, as well as in temporary structures erected to treat and house displaced earthquake victims RNRN volunteers also assisted with training and mentoring local Haitian nurses in providing intensive care services to seriously ill and injured patients
