

Support of TCC Academic Programs. This grant provided funding for TCC's Child Development (Infant/Toddler) Program, which trains childcare workers on early childhood development skills and effective teaching methods.

4b (Code _____) (Expenses \$ 316,853, including grants of \$ _____) (Revenue \$ _____)

Other Program Expenses for the year include \$86,849 to provide textbooks for students with financial need and \$40,295 to fund various college activities. The Foundation spent \$132,117 to support college capital projects and purchase equipment. These funds were used primarily to furnish and equip TCC's Center for Creativity, completed in July of 2010. Thirty-six laptop computers were also purchased for TCC's Middle College High School, a collaboration with Tulsa Public Schools designed to increase educational opportunities and graduation rates in the area. The Foundation spent \$45,991 in efforts to promote key relationships and support critical initiatives in keeping with the college's strategic plan and values in the communities we serve through sponsorships and program support. Finally, \$11,601 was spent to recognize college employees selected for excellence in job performance.

Support of TCC's Signature Symphony. This group of professional musicians plays a full concert season, mentors, and performs with TCC music students, and individual orchestra members provide music instruction to children in area public schools.
