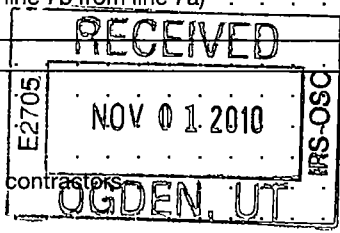

Part III, Line 28 - Program Accomplishments

World Citizens promotes three outstanding programs; Peace Education Workshops, International Peace Sites, and the Nobel Peace Prize Festival. These programs focus on empowering the education community to promote a just and peaceful world.

The Peace Education Program continues to expand by about 20-25 new participants a year. Since the beginning of this program, 211 educators from 82 schools have participated. We continue to increase the number of sessions by adding a group of 25 new educators each year. Six trained facilitators assumed the full time leadership role for all sessions in 2009-2010.

The International Peace Site program continues to grow each year. We added 7 new sites this year as well as supported rededications that were taking place throughout the year. New sites and rededications include schools, communities, homes, and many other places of business, government and worship. There are more than 200 Peace Sites in Minnesota and approximately 450 worldwide.

The Nobel Peace Prize Festival is held each year in cooperation with Augsburg College, the Nobel Peace Prize Forum, and the Norwegian Nobel Institute. Over a thousand youth participate in the festival activities ranging from displays on past Nobel Peace Prize winners to musical and dance performances.
