Life's WORC provides residential supports for over 215 individuals who reside in our 36 community based homes located throughout Queens, Nassau and Suffolk counties in NY. Each home offers a full range of supports and services consistent with the needs of our individuals and NYS Office of Mental Retardation and Developmental Disabilities (OMRDD) regulatory standards. More than 85% of our annual recertification audits by NYS-OMRDD have resulted in zero deficiencies, which is representative of the quality services we provide.

Life's WORC provides At Home Residential Habilitation (AHRH) services to approximately 120 children and adults throughout Queens, Nassau and Suffolk counties in NY. AHRH is designed to provide supports for individuals who reside with their family and require assistance in the development of independent living skills. This program also received a citation free audit from NYS-OMRDD, representative of the quality services we provide.

Life's WORC has six Day Habilitation programs located throughout Queens, Nassau and Suffolk counties in NY. The programs have been primarily designed to assist High School Graduates to transition into a work-type environment. All six of our programs received zero deficiency audits by NYS-OMRDD, which is representative of the quality services we provide.
