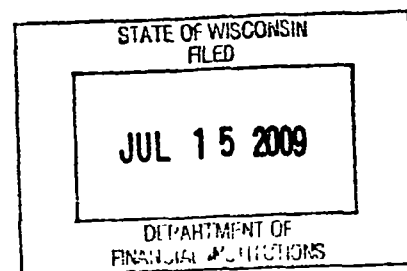

FRIENDS OF WISCONSIN PUBLIC TELEVISION, INC.



The following Amended and Restated Articles of Incorporation of Friends of WHA-TV, Inc., herein renamed Friends of Wisconsin Public Television, Inc., duly adopted pursuant to the authority and provisions of the Wisconsin Nonstock Corporation Law, Chapter 181 of the Wisconsin Statutes, supersede and take the place of the existing Articles of Incorporation and amendments thereto:

ARTICLE I

The name of the Corporation is FRIENDS OF WISCONSIN PUBLIC TELEVISION, INC.

ARTICLE II

The Corporation is organized exclusively for charitable and educational purposes, including but not limited to the following purposes: to support the educational, cultural and community broadcasting services of the Wisconsin Educational Communications Board (ECB) and the University of Wisconsin Board of Regents (UWEX), each an agency of the State of Wisconsin and operating their broadcasting services together as Wisconsin Public Television (WPT); to establish development services and other activities which complement and/or assist the broadcasting activities described above; to engage in other activities and programs ancillary to and in support of the foregoing; and to raise funds and invest in, receive, hold, use and dispose of property of all kinds as may be necessary or desirable to carry into effect the purposes stated in this Article.

ARTICLE III

The Corporation shall have all powers now or in the future given by law to nonstock corporations organized under the laws of Wisconsin, provided however that such powers may be exercised only to further the purposes stated in Article II above, and further provided that:

- (1) No part of the net earnings of the Corporation inure to the benefit of any private individual, except that the Corporation may pay reasonable compensation for services rendered and may make payments and distributions in furtherance of its purposes stated in Article II above;
- (2) no substantial part of the activities of the Corporation may be the carrying on of propaganda, or otherwise attempting, to influence legislation (except as otherwise

provided in subsection 501(h) of the Internal Revenue Code of 1986, as amended);

- (3) the Corporation not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office; and
- (4) notwithstanding any other provision of these Articles, the Corporation may not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV

The Corporation shall have members. Membership provisions, including the designation of one or more classes of members and the qualifications, rights, and method of acceptance of members of each class shall be as set forth in the Bylaws.

ARTICLE V

The affairs of the Corporation shall be managed by a Board of Directors. The number of Directors and their manner of election or appointment and their terms of office shall be as provided in the Bylaws, but the number of Directors shall not be less than three.

ARTICLE VI

The principal office of the Corporation is located in Dane County, Wisconsin, and its mailing address is:

ARTICLE VII

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation to one or both of the ECB and the UWEX for support of the educational, cultural and community broadcasting

services of WPT, as determined by the Board of Directors, provided that the UWEX and/or ECB then hold licenses for television broadcast issued by the Federal Communications Commission for the stations of WPT, or to such other entity or entities then holding such licenses provided that any such holder(s) are organized and operated exclusively for charitable, educational or scientific purposes as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or if the organization(s) holding such license(s) at the time of dissolution do not qualify as exempt under said Section 501(C)(3), as amended, then to such other organization or organizations that do so qualify as the Board of Directors shall determine.

ARTICLE VIII

The Articles of Incorporation may be amended by a vote of at least two-thirds of the Members of the Corporation present at a meeting duly held for that purpose, if the Bylaws provide for a vote of Members in this regard, or otherwise by the Board of Directors upon the vote of at least two-thirds of the Directors in office.

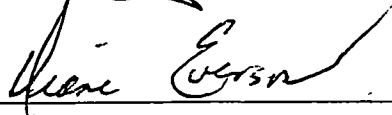
ARTICLE IX

These Restated Articles of Incorporation supersede and take the place of the heretofore existing articles of incorporation and all amendments thereto.

The undersigned officers of Friends of WHA-TV, Inc., herein renamed Friends of Wisconsin Public Television, Inc., a Wisconsin corporation with its principal office in Dane County, Wisconsin, CERTIFY: that said corporation has no members having voting rights with respect to the adoption of or amendments to the Articles of Incorporation of the Corporation, and that the foregoing Amended and Restated Articles of Incorporation of said corporation, which includes amendments to the existing Articles of Incorporation, were duly adopted in accordance with Section 181.1002 of the Wisconsin Statutes at a meeting of its Board of Directors on the 14th day of May, 2009, by the affirmative vote of at least two-thirds of the Directors then in office.
