Our Affordable Housing Trust has participated in the development of 284 units of affordable housing through partnerships with other non-profit housing developers This year we were in the process of retrenching, trying to collect on outstanding loans so that we could have funds available to invest in other affordable housing projects We did, however, do extensive rehab to our existing affordable housing project, remodeling bathrooms, installing new flooring, new stairs, new windows and plumbing upgrades We were not able to find any suitable partners or projects in this economic climate to invest our funds but are continuing to try to locate fiscally responsible partners and projects to invest in
