REQUEST FOR ABATEMENT OF LATE FILING PENALTIES

Form 990EZ for the fiscal year ended 6/30/10 (2009 tax form) was due on November 15, 2010. Prior to November, the officers of the organization requested that the tax preparer put the form on extension because information was not yet available.

Due to a computer error related to fiscal year returns in the accounting firm's tracking system, this entity's record was marked as complete and therefore did not come up on the tickler system as a return needing extension.

When the error was found, the accounting firm immediately informed the officers of the Masonry Industry Fund, gathered the necessary information and completed the attached Form 990EZ. Subsequent to this discovery, the accounting firm has reviewed its tickler system and corrected all errors related to fiscal year filers.

The taxpayer and its officers acted with due care to ensure that an extension was filed for the 2009 tax return, and the error which lead to the late filing has been corrected. Assessing a late filing penalty on the organization would cause undue hardship and take money away from its educational mission. We therefore request that the late filing penalties be abated for the year ended 6/30/10.
