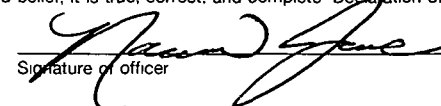

Take-home portion of Exam II (59 points of the total of 125)
This is due at the beginning of class on Wednesday, November 17.

1. Select a species of plant that was not covered in class , but that is a member of one of the genera we studied since the last test and provide the following information:
 - 1 the general character,
 2. identification characters,
 3. seasonal interest,
 4. landscape use (include important cultivars), and
 5. potential problems and diseases

The plant must be hardy to zone 5. You should write a short paragraph under each of the 5 headings. I want this to be a summary of the important information, not just a list of assorted characters.

Items to be considered in each section:

General character could include size, hardiness, texture, form, where will you encounter this plant etc.

Identification should include the important traits that will be helpful in separating this species from similar species and include the names of species we could confuse it with.

Seasonal interest comment on the qualities of the flowers, fruits, bark, summer foliage, etc

Landscape use includes descriptions of sites that would be appropriate for planting and how it could be used in landscape situations. Also list and briefly describe any important horticultural cultivars.

Culture/Problems and diseases will include information on growth requirements (sun, shade, soil, etc.) and include infectious and non-infectious diseases that limited the use of this plant.

2. List 3 cultivars of crabapples that have yellow fruit, are disease resistant and that you would recommend for use. 3 points.
3. List 3 cultivars of crabapples that have pink flowers, but are highly susceptible to disease and should be avoided. Make a notation of which diseases it is susceptible. 3 points
4. List 3 cultivars or species of crabapples that are noted for unique form, i.e. columnar, weeping, very dwarf, and are disease resistant that could be recommended. Note the form should be different in all 3. 3 points
5. List 3 cultivars of elm (genus *Ulmus*) that could be recommended for planting as a replacement for American elm (urban landscape plant) because of disease resistance. Include at least one that is a real American elm (*Ulmus americana*), and at least one that is another species or a hybrid species and make a note of these. 3 points
6. You have a client that loves magnolia flowers. Create a list of 4 plants (species and cultivar) in the genus *Magnolia* that you could include in a design that would provide maximum diversity of flower color, flower size, and provide flowers over an extended period of time. List the plants in order of estimated flowering time with the earliest flowering plants first and the latest last. Include notes on color and size of flowers. All plants should be hardy to zone 5 12 points
7. A real estate developer has hired you to plant street trees (space between sidewalk and road) in front of each home in a new subdivision. Your firm will be planting more than 200 trees. The sites will be in full sun and drainage and soil conditions should be considered ordinary. You have been requested to **create a list of 4 plants** that you will make available to the homeowners so that they can select the trees for in front of their home. You will need to select plants that will allow for automobile and pedestrian clearance. All plants should have good ornamental characters with few potential problems. Power lines are **NOT** present. You will need to **include a brief description of each plant** on your list that will be distributed to the homeowners. Cultivar names must be included when appropriate and include no more than one cultivar of the same species. Trees included on your list should come from the plants we have studied since the last test. This will be graded on quality and diversity of the plant selection along with clarity and professionalism of your narrative. 20 points
