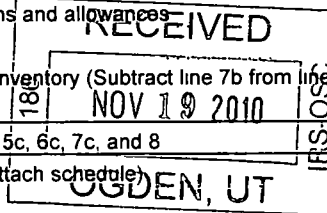



Description

The Foundation sponsors the Academic Bowl competitions at the elementary and middle school levels, supports Junior Achievement programs in elementary and middle school classrooms; hosts biennial cultural events for students and residents of the District, offers leadership incentive grants to students interested in attending leadership related events, and sponsors summer camps for interested elementary students in areas such as foreign language, science, computers, and language arts. The foundation also helps support various other youth programs.
