GOVERNMENT RELATIONSIn an effort to procure federal grant funds, MBC has contracted the lobbying group, Capitoline Consulting, to represent the organizational funding needs for Bidwell Training Center, Manchester Craftsmen's Guild and the National Center for the Arts and Technology. By securing the necessary governmental support, the MBC model is able to be replicated nationally and internationally. To date Capitoline has helped secure a grant to help fund the new Electronic Medical Assistant program in Bidwell Training Center.
