The Alive in Christ campaign is a multi-wave, multi-year capital campaign with a goal to raise \$150 million, of which \$90 million will be returned to parishes for capital improvements, debt reduction, parish or school endowments, and other projects. The campaign began in spring 2008 and the fundraising phase is projected to continue through early 2011. Alive in Christ is the platform for numerous parish and Diocesan initiatives.

The Foundation development staff provides continuing assistance to both the Diocese and individual parishes for current and future development activities through its Diocesan Stewardship and Development services, including Our Catholic Appeal, the parish based annual collection to support the operations of the Chancery and its programs and ministries. Our Catholic Appeal is based on a schedule of assessments prepared by the Chancery in conjunction with the pastoral leadership of the Diocese. The annual goal for Our Catholic Appeal was \$12,250,000 in 2010.
