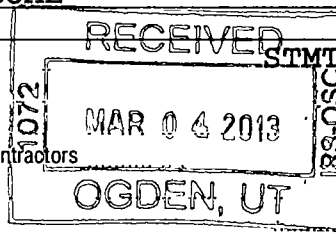

TO CARRY OUT ANY PROJECTS FOR THE BETTERMENT OF THE BOOSTER CLUB, ATHLETIC PROGRAMS, OR ACADEMIC PROGRAMS OF HASTINGS PUBLIC SCHOOLS.
