THE EVENT WAS AN EVEN BIGGER SUCCESS THAN THE PREVIOUS YEAR, SEEING OVER 50,000 PEOPLE IN ATTENDANCE AND FEATURING OVER 450 NOTABLE AUTHORS, POETS, PUBLISHERS, LITERACY GROUPS AND CULTURAL ORGANIZATIONS. THIS YEAR'S FESTIVAL FEATURED MANY EVENTS, INCLUDING A PARADE OF FAMOUS CHILDREN'S BOOK CHARACTERS FEATURING THE WILD THINGS AND THE HUNGRY CATERPILLAR, CIRCUS ACTS OF LITERARY THEMES PERFORMED BY THE LINDLEY LOPEZ LITERACY CIRCUS, A SCIENCE PAVILION FEATURING A SCIENCE WRITING PANEL, AND A TV CULINARY AREA WITH COOKING DEMONSTRATIONS FEATURING WELL-KNOWN LOCAL CHEFS...WHICH WERE ALL PROVIDED FREE TO THE PUBLIC.
