Its mission is to create and support a network of K-8 public schools in under-served communities that provides students with the academic skills and critical-thinking abilities they need to succeed in a college-preparatory high school. There are currently 700 students enrolled in the network's two charter schools in central Brooklyn. To realize its mission, Explore Schools provides value-added support to the schools within the network, while at the same time developing capacity to establish and support turnaround schools that will provide students in under-served communities with access to a high-quality public education.
