WARMING AND ALLEVIATE THE CONSEQUENCES OF CLIMATE CHANGE, AS WELL AS PROMOTE  
LIFESTYLE CHANGES FOR INDIVIDUALS THAT CAN HELP TO ALLEVIATE GLOBAL WARMING. WE  
CONVENED TWO NATIONAL EDUCATIONAL CALLS ABOUT CLIMATE CHANGE FOR MEMBER  
ORGANIZATIONS AND OTHERS, AND MADE INFORMATION AVAILABLE ON OUR WEBSITE.
