

THE ORGANIZATION WAS ESTABLISHED TO CREATE A STATEWIDE, STANDARDS-BASED ELECTRONIC HEALTH NETWORK WHICH WILL ALLOW INDIVIDUAL ALASKANS TO HAVE THEIR OWN PERSONAL HEALTH RECORD AND TO AUTHORIZE THEIR HEALTH CARE PROVIDERS TO EXCHANGE ELECTRONIC MEDICAL RECORDS IN A TIMELY, SECURE MANNER. THE CORE FUNCTION IS THE MANAGEMENT OF A SECURE ELECTRONIC NETWORK, CALLED A HEALTH INFORMATION EXCHANGE, WHERE MEDICAL PROVIDERS SHARE IMPORTANT MEDICAL INFORMATION WITH THEIR PATIENTS.
