


STATEMENT FOR REASONABLE CAUSE FOR LATE FILING

Paine Elementary PTO is a domestic non-profit corporation organized under the laws of the State of Alabama in September 2009. The Organization was organized exclusively for charitable and educational purposes in support of Trussville, Alabama elementary schools. In 2015, the Organization elected new officers. The newly elected officers discovered that, dating back to the Organization's inception, Form 990-EZ and Form 1023 Application for Recognition of Exemption Under 501(c)(3) of the Internal Revenue Code, had not been filed. Upon this discovery, the officers took immediate action by engaging a local CPA firm to prepare all prior and current year Form 990-EZ Short Form Return of Organizations Exempt from Income Tax returns. Additionally, the Organization will be preparing and submitting Form 1023 to the Internal Revenue Service to be recognized as a tax exempt organization.
