CFC conducted the raffle on their website, provided marketing, public relations and e-mail expertise as well as administrative expertise. CFC collected the funds, paid the prize, fulfilled all tax requirements and paid the expenses.

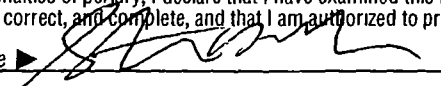
