




Everett Youth Hockey Booster Club helps enhance a hockey program for youth in the Greater Snohomish County area for players ranging in age from 4 to 18 years old.

The organization purpose is to establish and maintain a not for profit organization to carry out its' goals. The goals are to help youth be involved in hockey activities to help learn: teamwork, self-discipline, and respect for others while building self-esteem and social skills.

This is done by providing equipment, clothing, open skates, and mentoring for the youths of the community and scholarship opportunities to the hockey league.

The organization raises money through fundraisers, membership fees, and donations.
