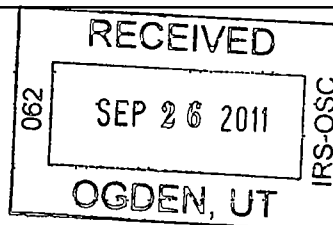



Everett Youth Hockey Booster Club helps enhance a hockey program for youth in the Greater Snohomish County area for players ranging in age from 4 to 18 years old.
