Scholarships for PHD and Masters students from numerous African countries Over 50 NEGST students benefited from CLA scholarship donations during this past academic year Many received full scholarships of \$3000 These scholarships applied to tuition and in some cases housing costs for the students The CLA executive director monitored the progress of each of these students, meeting most of them in person during his campus visit in February, and consulted with the Financial Aid director at NEGST about their financial needs CLA also supports the doctoral students at NEGST The current cohort of 12 students is in its final year of study, much of which was funded earlier by CLA donors A new Ph D cohort will begin in January, 2010

One of CLA's major projects is the expansion of the library resources and capabilities Matching grants have been obtained by CLA to upgrade the collection in areas where doctoral programs are being developed The funds raised during this past year were applied to book purchases in areas such as Biblical Studies, Missions and Islamics, journal subscriptions, computers, tables, chairs and book shelves The furniture items were needed as the NEGST library expanded into the second floor of its current building
