Establishes quality assurance standards for the operation of all domestic violence programs statewide, coordinates 21 peer reviews, and provides technical assistance and support to reviewed programs. Conducts annual statewide conference for 246 professionals and advocates for a statewide crisis hotline.

Federal Family Violence Prevention -

Supports comprehensive public awareness activities of the agency, training education, system and individual advocacy, membership services, batterers' intervention program certification, and programming for underserved populations.

Protective Order Pro Bono Project (POPBP) and Victims of Crime Act (VOCA) -

POPBP - The legal resource project provides legal representation and direct service advocacy to low income victims of domestic violence and stalking seeking assistance in filing and enforcing orders of protections in Marion County Superior Court. The legal resource project assisted over 3,500 individuals.

VOCA - Provides direct service to approximately 4000 victims of family violence through legal representation, advocacy, crisis counseling, information and referral, and the operation of a statewide toll-free crisis line.

S.T.O.P. Training and Coalition -

Provides training and education to over 4,000 professionals statewide, distributed over 54,000 pieces of education materials, conducted over 100 trainings and responded to over 66,000 requests for technical assistance to member programs, public and private agencies, and victims. Provides for coordination and collaboration with all federal, state, and local entities to improve systems response and victim services.




