The mission of the Women's Foundation of Southern Arizona is to foster equity and opportunity for women and girls The Foundation fulfills this mission by using a comprehensive process to grant funds to an array of programs in southern Anzona (Pima, Cochise and Santa Cruz counties) that promote economic self-sufficiency for women and girls, by providing innovative programs to increase women's philanthropy and leadership, and by conducting research on issues affecting women and girls in southern Arizona In the spring of 2009, we awarded \$89,461 90 through our general, annual grant round to six organizations that promote women's economic self-sufficiency Using a variety of strategies, five of these programs provide women with job training, financial literacy, family planning and tutoring to enable them to support themselves and their children The sixth program, through the Girl Scouts, provides girls who have been incarcerated or who are at risk of being incarcerated, with life skills and leadership training to assure successful futures We funded the second year of our Equity and Opportunity Fund in 2009-10 These three-year, \$75,000 grants were awarded to two exemplary organizations to increase women's economic self-sufficiency through financial literacy, asset building, employment and home ownership Aimed at building the economic securty and financial independence of low-income, women-headed families, our goal is to help ensure women are better equipped to provide for themselves and their families on a long-term basis We also trained 15 young women in Tucson on social justice issues, philanthropy, leadership and grant-making through our award-winning girls' philanthropy program, Unidas Through Unidas, high school girls design and implement a grants process, review applications and conduct site visits In 2010 the girls allocated \$6200 to the Sahuaro Girl Scout Council for a program to decrease teen dating violence Unidas participants also learned fundraising skills, raising approximately \$20,000 toward a \$25,000 challenge pledge from a family foundation
