	The traditional undergraduate program consists of "traditional" residential or similar students attending school as their primary activity, mostly full-time during the day-time hours. Programs include 44 academic majors, including 13 interdisciplinary majors, 9 pre-professional programs, including pre-medicine and pre-law, teacher licensure in 9 areas, and 16 international exchange study programs in 11 countries. The newest programs include engineering and nursing. Also available is the professionally-staffed Center for the Advancement of Learning, which also includes the PLUS Program for students with handicapping learning conditions, all with a strong base in the liberal arts.

	The Graduate and Continuing Studies program consists of programs designed for those seeking post-graduate certification or those who have spent more than two years since completing any secondary or post-secondary work. Many balance their study with work and family responsibilities. Programs offered include Master of Arts and Education, with specializations, Master of Arts in Teaching, with specializations, Master of Information Strategy, Systems and Technology, Adult Degree Completion (Muskingum Adult Program). In 2009, Muskingum began a BSN in Nursing for area RN's.

Effective July 1, 2009, the University adopted changes issued by the FASB to accounting for income taxes. These changes prescribe a comprehensive model for how an entity should recognize, measure, present and disclose in its financial statements, uncertain tax positions that it has taken or expects to take on a tax return. This guidance requires that an entity recognize in its financial statements the impact of tax positions that meet a "more likely than not" threshold based on the technical merits of the position. This guidance also clarified how an entity should determine whether a tax position is effectively settled for purposes of recognizing previously unrecognized tax benefits. The adoption of this guidance had no impact on the financial statements.
