MaineGeneral Medical Center is a non-profit acute care hospital with facilities in both Augusta and Waterville, Maine, that provide comprehensive healthcare services to the community, regardless of a patient's ability to pay Both campuses provide emergency and critical care, a full range of inpatient and outpatient surgical services, substance abuse and mental health services, cancer care, maternal, newborn and child health services, and inpatient and outpatient diagnostic services In addition, the Jackman Region Health Center in northern Somerset County, which is a part of MaineGeneral Medical Center, provides physician office services and an 18 bed nursing home During the fiscal year ending June 30, 2010 MaineGeneral Medical Center provided care for 12,376 inpatients, 2,393 inpatient and 8,645 outpatient surgenes, 1,217 births, 56,001 oncology proceedures, 746,664 laboratory proceedures, 107,378 diagnostic imaging procedures, and 63,418 emergency procedures

MaineGeneral Health Associates is a non-profit organization that provides primary care and specialty healthcare services to patients in the Kennebec Valley Region regardless of a patient's ability to pay MaineGeneral Health Associates also keenly focuses on preventive health and supports many ongoing services throughout its surrounding communities During the fiscal year ending June 30, 2010, MaineGeneral Health Associates provided \$600,559 of charity care to patients who were unable to pay for services In addition, the physician practices provided a total of 166,993 primary care and 123,623 specialty care visits during the year ending June 30, 2010
