	HAITI Plant With Purpose extended its work to 70 villages with 2,603 members Community members reforested seven watersheds by planting over 500,000 trees and attended over 50 financial management trainings to improve their business skills Plant With Purpose also made significant progress in providing assistance to local churches in their outreach and service to their communities by providing bible study curriculum and training for pastors Furthermore, in response to the earthquake on January 12, 2010, Plant With Purpose’s local Haitian staff distributed nearly 250,000 pounds of rice and 15,612 liters of cooking oil to 5,500 people throughout 45 communities, enabling families who would have otherwise been unable to feed their loved ones Plant With Purpose employed over 4,300 farmers through a “Cash for Work” program to plant over 240,000 trees and construct over 360 miles of soil erosion barriers

	DOMINICAN REPUBLIC In 2010, Plant With Purpose partnered with 2,500 people in 52 villages in the Dominican Republic 180,184 trees were planted in agroforestry and reforestation efforts across 356 acres, restoring the land, preventing erosion, and improving families’ livelihoods 44 microloans were granted, totaling \$17,142 for farmers to start small businesses or invest in their land In our project along the Haitian/Dominican border eight new lending groups were formed and trained in cooperative savings and loans management Already, these groups have accumulated \$2,500 in savings We are in the process of transitioning to primarily savings-led lending, and these eight groups are part of an exciting pilot savings project that will have implications for all of Plant With Purpose’s savings and loans programs around the globe 205 lay leaders were trained and 59 new Bible study groups were established as a result of Plant With Purpose’s partnership with 64 rural churches, fostering community, discipleship, and spiritual growth Our work on the Haitian/ Dominican border expanded from six to eight villages Farmers of both nationalities are demonstrating a strong camaradene as they work together to overcome poverty and revive their communities
