Many times these activities provide low or negative margins. The community of the organizations encompasses more than geographic boundaries, but embraces the disadvantaged and encourages the under-served to seek help for the treatable illness of addiction. As a nationally recognized, quality provider of addiction treatment, the community benefit provided is an outward and tangible expression of the mission and culture of the organization, its values, integrity and compassion.

NKRC is a wholly owned subsidiary of Pittsburgh, Pennsylvania based Gateway Rehabilitation Center (GRC). GRC is recognized nationally as a leader in the treatment of drug and alcohol addictions. The mission is to help all affected by addictive diseases to be healthy in body, mind and spirit. The GRC network of service includes 20 licensed programs and four additional intervention programs for youth at 20 sites throughout western Pennsylvania and Ohio. Approximately 1,700 people can receive treatment daily within this network. NKRC has one inpatient site at its main campus in Youngstown, Ohio and three outpatient offices located in Austintown, Dublin and Howland, Ohio. Adults at NKRC can access a host of programs, including inpatient rehabilitation, medical detoxification and outpatient treatment at several levels. NKRC operates a residential housing, gender specific program for women who need daily treatment but who live in an environment non-conducive to recovery. Youth programs include outpatient treatment as well as prevention programs in venues where positive lifestyle choices are encouraged. Some financial assistance is available for those individuals who do not have insurance or another means to pay for treatment.
