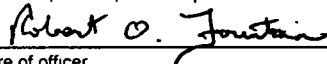
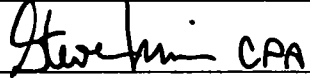

During fiscal year 6/30/2008, the DCA committed to contribute \$20,000 per year for five years to the Athletic Department of the University of Toledo. The funds are to be used to offset part of the costs to renovate Savage Arena, home to some of the University's varsity teams. The current year's payment represents the second of five such payments.

Statement 6 - Form 990-EZ, Part III, Line 30 - Statement of Program Service Accomplishments

Description

The DCA organizes weekly buffet luncheons for its members. One or more University of Toledo Coaches will speak to the members and guests. These buffet lunches provide a forum to promote public interest and support for the various intercollegiate athletic programs at the University. Members and guests pay for their own lunches. The revenue is included in Part I, line 2. Approximately 2,400 members, coaches and athletic department officials participated during the year.

Statement 7 - Form 990-EZ, Part III, Line 31 - Statement of Program Service Accomplishments

Description

Direct payments to the University's track team, swim/dive teams and women's golf team as additional support for those programs. The grants are used for the purchase of equipment, supplies and travel. Approximately 195 student athletes benefited.
