Briefly describe the organization’s mission

ICAN is a community development organization established in 1988 to provide permanent, affordable housing to homeless persons with severe and persistent mental illness. Its tax exempt activities include continuing outreach to identify homeless persons who exhibit signs of mental illness, finding temporary shelter and other necessities for homeless persons, connecting such individuals for a clinical assessment, providing constituents with access to permanent, affordable housing and providing support services to encourage successful independent living.

The population served by the ICAN Apartment Program is households who were homeless at the time they entered ICAN Housing. The head of the household must have a diagnosis of major mental illness. Eligibility is based on households' histories of homelessness and their incomes. Incomes below 35% of AMI. Their housing stability is marginal at best. ICAN owns, manages, and maintains 22 properties. The property types range from group homes and single room occupancies to multi-bedroom single homes which include 20 efficiency units, 59 one bedroom units, 5 two bedroom units and 3 homes with three or more bedrooms throughout Stark County. Residents pay no more than 40% of their income for rent, including utilities. ICAN Apartments are permanent until the resident chooses to move on. Residents of the ICAN Apartment program receive mental health services from five community behavioral health centers. Most ICAN owned buildings have no on-site staff. Two Housing Specialists assist residents in learning how to fulfill their lease obligations so they retain housing. The ICAN Apartment Program responds to typical needs of the population arising from their vulnerability to emotional upheavals. They tend to vacate apartments or undergo eviction when these needs are not met. clients who were tenants - over 300.

Rent Subsidies Program - provides permanent supportive housing for another approximately 200 disabled homeless households. ICAN works with landlords who understand its customers and accept rent vouchers. ICAN has tracking and record keeping systems that comply with HUD’s requirements. ICAN uses the rent subsidies to help customers obtain and retain stable housing, and to receive supportive services. New this year was ICAN’s participation with Stark County’s HUD based Homeless Prevention and Rapid Rehousing Program. As a contract provider, ICAN counseled and provided rental assistance to 29 households to prevent eviction.

Homeless Outreach Program - provides resources and supports to help customers obtain the essentials of life, including food, shelter, clothing, emergency loans and access to health and social services.
