Strategic Investment Initiative For the past six years, NPI has carefully targeted resources to areas within the City that have strong locational assets, an engaged community, and effective CDC's Through a competitive grant process, the Strategic Investment Initiative supported the work of six 501(C)(3)community development corporations during FY 2010 NPI's goal is for each neighborhood to build on assets, support residents in healthy living and positive options for housing and employment, and become neighborhoods of choice In FY2010, the SII CDC's built or rehabbed 332 housing units, including 170 rehabs and 162 new construction units with 166 for low to moderate income families, and built or renovated over 400,000 square feet of retail, commercial, or institutional space, including the new Harvey Rice Learning Campus in Buckeye, the Capital Theatre in Detroit Shoreway, and the Global Cardiac Innovation Center in Fairfax A key component of its SII, NPI implements a very successful "Model Block" program that provides small grants and matches homeowners in designated model blocks with other resources for the purposes of exterior repairs and landscaping aimed at creating a sense of community pride In the past year, 48 homes were repaired, 27 landscaped, and 10 lots were greened

Opportunity Housing NPI partners with the Cleveland Housing Network (a 501(C)(3) organization), CDC staff, the City of Cleveland and foreclosure prevention agencies in six neighborhoods on this comprehensive approach to eliminate blight and restore market confidence Opportunity Housing is a three-tiered program consisting of the renovation of homes that have become vacant through foreclosure, demolition of vacant and abandoned homes not suitable for renovation, and-through counseling, organizing and advocating for families in distress-preventing families from losing their homes through foreclosure This initiative builds upon a network of strong community development organizations the 27-year track record of the Cleveland Housing Network, the financial and development capacity of NPI, the CDC's ties to the neighborhood and residents, ESOP's proven track record in facilitating loan modifications and workouts, and a commitment of the City of Cleveland to target resources and programming to these six neighborhoods that will support them now and in the future as great places to live Since its inception in 2008 through the end of FY2010, the Opportunity Housing initiative supported the acquisition and rehab of 46 homes, the demolition of 128 blighted structures, and 56 foreclosures averted

Neighborhood Stabilization Team With new mortgage foreclosure filings in the City of Cleveland peaking at over 6,000 in 2007 and averaging at approximately 4,400 annually since, the NPI team has remained steadfast and dedicated to stemming the damaging wake of vacancies and blight left behind and protecting the assets of Cleveland's rich neighborhood fabric through innovation, investigation and policy reform NPI's Neighborhood Stabilization Team ("NST") provided technical and tactical assistance to community development corporations in 14 neighborhoods in FY2010, utilizing a web-based data application hosted by Case Western Reserve University's NEO CANDO data system In order to have the most impact possible, finite resources and time require this strategic targeting of stabilization efforts with a thoughtful focus on the relationship between community assets and destabilizing factors
