We have partnered with Midtown Cleveland CDC, another economic development non-profit organization, to develop additional, affordable incubator space in the region. They also can request access to certain equipment for a reasonable cost at the regional research institutions, Cleveland Clinic Foundation and Case School of Medicine

Austen BioInnovation Institute - BioEnterprise was a substantial factor in the Institute's creation. BioEnterprise worked with Akron Children's Hospital, Akron General Hospital, NEOUCOM, Summa Health System and the University of Akron to found the Institute. BioEnterprise assisted the Institute in obtaining funding from the Knight Foundation (\$20M commitment), the State of Ohio (\$20M commitment) and Partners (\$20M commitment). The Institute will develop the following Centers of Excellence: Biomaterials and Medicine, Medical Device Development Center, Clinical Trials, Healthcare Training and Community Outreach to the medically underserved. Their mission is to expand Akron's rich legacy in material science, and to pioneer the next generation of life-enhancing and life-saving biomedical innovations for the 21st Century. In FY 2010, \$1.15 M in Federal funds were secured. An Ohio Third Frontier Wright Center proposal for \$3 M was also awarded.

Medical Imaging - Northeast Ohio is well known for its medical imaging industry. BioEnterprise is in the process of catalyzing this cluster of business. This cluster would improve the economic development in the distressed area of Northeast Ohio. BioEnterprise participated in many meetings during the fiscal year that resulted in the establishment of the Philips Global Advanced Imaging Center at Case Western Reserve University and a \$38.6 M commitment, including \$5 M from the State of Ohio. Imaging clients attracted \$7.2 M in additional funds for their companies.

Health-Tech Corridor - BioEnterprise has supported the development of a public-private initiative to develop the Cleveland Health-Tech Corridor, an area that encompasses 1600 acres that includes and connects the leading health care and research institutions in the

region. The collaboration attracted the financial support and designation as an innovation zone from the City of Cleveland, Cuyahoga County, and the State of Ohio

TiE Ohio - BioEnterprise continued during the fiscal year encouraging the expansion of this chapter of immigrant entrepreneurs in northeast Ohio to access talent, ideas and enterprise to improve economic development in the region. The organization had 132 members at end of the fiscal year.

BioEnterprise presented the following events for the bioscience cluster to improve its efficiency, knowledge and economic development: Private Equity Event (121 attendees), CEO Event (67 attendees), and Opportunities for bioscience companies with USDOD agencies (86 attendees). BioEnterprise also continues to work with local community colleges to create and promote programs to train individuals in bioscience manufacturing

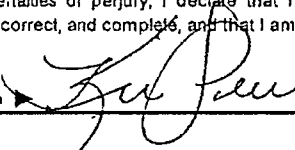
