Net Patient Service Revenues and Patient Accounts - Receivable Patient service revenue and patient accounts receivable are recorded at the net realizable amounts based on established charges when the patient service is rendered. The Center has agreements with third-party payers that provide for payments to the Center at amounts different from its established rates. Payment arrangements include prospectively determined rates per discharge, discounted charges and per diem payments. Charges for services to patients are primarily based on the patients' ability to pay. The allowances offset against patient accounts receivable represents management's estimate of the expected losses to be realized, and is based on historical experience, current economic conditions, and other relevant factors. Interest is not charged on outstanding accounts receivable. As of June 30, 2010 and 2009, the allowances totaled \$4,664,225 and \$3,938,951, respectively. Of the total allowance amounts, \$2,940,902 and \$2,414,981 as of June 30, 2010 and 2009, respectively, related to uncollectible bad debts on self-pay accounts. Included in net patient service revenue are reimbursements from Medicare, Medicaid, Commercial payors and self-pay patients. Charity Care - The Center provides care to clients who meet certain criteria under its charity care policy without charge or at amounts less than its established rates. Because the Center does not pursue collection of amounts determined to qualify as charity care, those amounts are not reported as net client service revenue. Estimated charity care provided in 2010 and 2009 was \$5,579,352 and \$4,809,409, respectively. "Cost" of Bad Debt was computed by multiplying the Center's Bad Debt expense (recorded based on net patient revenues) by the "patient care cost to charge ratio" computed per IRS instructions and the accompanying worksheet. 89% of the center's self-pay revenues are subject to a charity care discount. We used this 89% times the "cost of bad debt" to determine the additional community benefit provided to our consumers.

The Center accepts assignment from Medicare for the reimbursement of services provided to our clients and thus is unable to bill the consumer other than for deductibles and co-pays. To the extent that Medicare's reimbursement and consumer deductibles and co-pays are insufficient to cover our costs, this represents a "community benefit." The amounts reported on lines 5 and 6 are from the Medicare Cost Report for inpatient services. These amounts do not include outpatient services.

Upon admission for services, consumers are requested to provide documentation of income. Based on information provided, consumers are assigned a discount percentage for subsequent services. The discount percentage is applied against the "gross charge" for services and consumers are expected to pay the remaining balance. Should consumers experience difficulties in paying the discounted fees, we provide additional "payment plan options" as well as further discounts up to and including the full write-off of the balance as warranted by individual facts and circumstances.

The Center has a standardized admission process for all consumers. As part of the admission process, consumers are requested to provide income documentation in order to qualify for discounted fees. Consumers are informed of the standard fees for services, discount fee schedule, charity care policy, and are provided a copy of their financial agreement that summarizes these items. Copies of our fee schedule, discount schedule, and charity care policy are placed in all admission departments. Consumers with third party payor sources are matched with eligible providers to ensure reimbursement of services. For consumers that do not have third party payor sources and that meet Medicaid criteria (financial and clinical), we provide extensive assistance to facilitate their enrollment in Medicaid.
