The Center provides comprehensive mental health services to the residents of Cass, Fulton, Miami, and Pulaski Counties on both an inpatient and outpatient basis. Care is provided to patients who meet certain criteria under its charity care policy at amounts less than its established rates. The Center does not pursue collection of amounts determined to qualify as charity care. The amount of charges foregone for services and supplies furnished under the Center's charity care policy is \$3,011,975 in 2010. The amount includes reductions in fees based on the client's ability to pay and client services performed free of charge. Please contact the financial department for additional details related to the Center's exempt purpose.

Part I, Line 3c The criteria that Four County uses to establish need for free or discounted care is based on annual family income and number of dependents Patients whose household income falls below 100% of the Federal Poverty Level are eligible to receive a 100% discount on services If the household income of a patient falls between 100% and 200% of the federal poverty line, with respect to the size of the family unit, the patient qualifies for a 60% discount on fees This policy is in place to ensure that indigent clients are treated fairly and appropriately in the collection process with respect to their ability to pay

Part III, Line 4 Bad Debt Expense is calculated based on patient receivable accounts which are deemed uncollectible after every reasonable effort to collect the amounts due to the organization have been exercised with regard to charity care, the center does not pursue collections of amounts determined to qualify as charity care, so these amounts are not included in bad debt expense A cost to charge ratio was used to calculate estimated charity care at cost The cost to charge ratio is calculated based on the ratio of patient care cost to charges To determine the costs that are included in calculating the above amounts, a cost report is utilized which determines total program inpatient and outpatient costs, and total inpatient and outpatient medicare reimbursements received

Part III, Line 8 The amount of medicare allowable costs that are reported above are calculated in a cost report which determines total inpatient and outpatient charges and establishes the amount of dollars that have been received from medicare for both inpatient and outpatient patients and procedures

Part III, Line 9b For those clients who are known to qualify for charity care or financial assistance, the appropriate discount of fees is applied at the time of service. Additionally, payment arrangements are able to be entered into based on income and individual circumstances. These payment arrangements are approved by the chief financial officer/business officer manager. Payment Arrangements exist to recognize the ability of the patient to pay, as well as pay respect to the fact that, in fairness to paying clients, it must make every reasonable and customary effort to collect for services provided. By doing so, the center can remain a viable organization and continue to provide the needed services to the communities it serves.

Part VI, Line 2 Surveys are used to establish the needs of each of the four counties that the organization serves. These surveys are promoted through radio and newspaper venues, as well as through multimedia outlets such as the company website and the social network, facebook. These client satisfaction surveys are used to meet the needs and concerns of these clients. The website and facebook are used to encourage the public to make comments or ask questions pertinent to the mental health field. The organization attends local health fairs to educate the public about mental health and to speak with the public about health concerns. The organization also presents at local venues such as schools to actively interchange information and concerns with the public it serves. Free mental health screenings are periodically offered at various sites in the community at at homes upon request in order to develop a more rounded picture of the general mental health of the community it serves. The mental health screenings are also available on the organization's website. The organization also regularly works with each of 11 local school districts, local hospitals, doctors offices, government facilities, businesses, libraries, health facilities, and law enforcement facilities to gather mental health information about the community and the individuals who reside in it.

Part VI, Line 3 Clients or responsible parties are informed of their financial responsibility upon admission, or as soon as practical by the discharge date. Clients are encouraged to complete a financial assistance application as well as an application for Medicaid when applicable -- these clients are assisted by Four County associates as much as possible. Those who are not insured and/or who meet poverty guidelines are informed of the charity care policy that is in place at four county mental health center. If the client falls below the 200% Federal Poverty Guideline, he or she is offered a full fee discount for services provided by the inpatient unit. The client must provide information that substantiates his or her household does not possess sufficient liquid assets to meet his or her financial obligation in order to qualify for reduced rates at Four county counseling center.

Part VI, Line 4 Four County Comprehensive Mental Health Center, Inc serves primarily four counties located in rural (population of less than 100 per square mile) northern Indiana - Cass, Miami, Fulton, and Pulaski. Population figures from the 2010 US Census are respectively 38,966, 36,903, 20,836, 13,402. The demographics are as follows 93% white race with highest non-white race Hispanic/Latino at 5.4%. Of the four counties, Cass county has the highest Hispanic/Latino race at 12.6%. 76% of the residents are over 18 years old. Three of the counties have a poverty level that is under the state average of 14.4%. Three counties average a poverty level of 12.9%. The exception is Miami county which has a poverty level 18.1% above the state average with 17% of residents at poverty level. The median household income of the four counties averages \$41,622. Records for poverty levels and income are obtained from the 2000 US Census and Indiana Business Research Center.

Part VI, Line 5 Four County offers community support through its activity and leadership with each of the counties lead service organizations Cass Co Resource Network, Fulton Co Service Providers, Miami Co Service Coalition, and Pulaski Co Service Providers. The organization works with and supports each of the Mental Health Associations in the counties and offers Bridges Enterprise and other job shadowing work programs to prepare individuals for employment. The organization prepares individuals with the physical, emotional, and mental skills necessary for work activity. Four County is a lead agency in the Better Health of Cass County and has written a grant to support tobacco cessation in the county. The organization offers continued support to the county health agencies.
