PIKES PEAK HABITAT FOR HUMANITY (PPFH) is a Christian Housing Ministry that builds simple, decent affordable homes in partnership with the community and prospective homeowners. Over 100 homes have been sold to qualifying, low-income families and financed with zero-interest mortgages for up to 30 years as chosen by the homeowner.

Building Simple, decent, affordable homes for sale at cost to eligible, low-income families. During tax year 2009-2010, 15 homes were sold to eligible families. Expenses are the costs incurred to build the homes. Revenue consists of the mortgages on homes sold, mortgage discount amortization, and Restore sales. PPFH also services the mortgages on the homes sold to the low-income families. The families can select 20, 25, or 30-year mortgages. Their monthly payments include both repayment of the mortgage and escrow to cover insurance, property tax and dues. The PPFH ReStore sells recycled, gently used building and home improvement supplies.
