Habitat for Humanity of Monroe County, Inc. (HFH) is a not-for-profit Indiana Corporation with the purpose of providing residential housing for low income families who have been residents of Monroe County and adjacent counties for at least one year at a cost they can afford. Families who purchase homes are identified by the Family Selection Committee who uses predetermined criteria which does not consider race, gender, nationality, age, handicap, religion, marital status or source of personal income. An approved applicant must provide 250 hours of "sweat equity", maintain the home as required by the mortgage contract, and participate in HFH's nurturing program which provides education and counseling.

HFH homes are sold at a predetermined price which is below cost, and HFH provides and services no-interest mortgages to the home buyers. For accounting purposes, the mortgages are discounted using an imputed interest rate of 8%. The discounts are amortized on a straight line basis over the life of the mortgage.
