Expenditure Responsibility	Form 990-PF, Part VII-B, Question 5(c)	During the year, PIC International, Inc (hereafter referred to as "the Organization") made a grant to a non-public charity for use in overseas mission work. However, it did not fulfill all steps to be considered as having exercised expenditure responsibility as required of private foundations. The grant was made to support mission work of the Odessa Theological Seminary and the Baptist Churches in Ukraine. These organizations perform charitable work, but are not recognized as being exempt under the US tax code. The Organization was in the process of applying for and expected to become a public charity in April, 2010, when the grant was considered and made. The Organization performed the due diligence, required of a public charity. In December, 2010, the Organization subsequently determined it would not qualify as a public charity. At the time of the grant, it was not anticipated that the more stringent expenditure responsibility rules, required of a private foundation would apply. The Organization believed it met all requirements to make a grant for this charitable purpose. On March 9, 2011, tax exempt status was granted classifying the Organization as a private foundation under the meaning of section 509(a) of the Internal Revenue Code. Acting in good faith, the Organization's management performed due diligence prior to making the grant. Management researched the grant recipient and was satisfied with the charitable nature of the organization and the capability of administering the funds in accordance with the charitable nature of the Organization. Pre-grant inquiries, led to the determination that this grant met the charitable purpose of the Organization. Subsequent to making the grant, the Organization has monitored the use of the funds to ensure they were spent in accordance with the Organization's charitable purpose. In addition, written reports have been received from the grantee during and at the completion of the grant period. While the Organization did not comply with the sequence of steps in achieving expenditure responsibility, the Organization did meet the requirements of a public charity to ensure that the grant was spent in accordance with the charitable purpose of the Organization. Subsequent to June 30, 2010, the services of Foundation Source (a foundation management firm) were retained to ensure full compliance with expenditure responsibility on all future grants. Based on the facts and circumstances outlined above, the Organization believes that it would not be reasonable to expect the entity to comply with this requirement during the time period when it believed it qualified as a public charity. Therefore, we respectfully submit the facts outlined above to show that every effort of compliance was made and request that the Organization be exempt from any penalty or excise tax that may be assessed for the current period.
